Present: Councillors Dunning, Greenberg, Moseley and Pattison, the Town Clerk and two members of the public. Cllr. Hedges joined the meeting during Item 7

- 1. Election of Chair In the absence of the Committee Chair and Vice-Chair, Cllr. Moseley was proposed, seconded and APPROVED as the Chair for the meeting. Cllr. Moseley welcomed all to the meeting and advised that there would be no recording of the meeting
- Apologies. Received from Cllrs Hedges (part) and Took (other commitments) and APPROVED.

- 3. Minutes of the last meeting

**RESOLVED** - to approve the minutes of the Finance & Governance Committee meeting held on Monday 20<sup>th</sup> November 2023 as a true record.

- 4. Public Forum. A member of the Trustees of the Millenium Green sought the Council's support for a celebratory event on February 24<sup>th</sup>, to celebrate 25 years of its existence. The Trustees were invited to contact Phillipa Salvoni, the Council's Town Marketing contractor, to assist in promoting the project.
- 5. Clerk's Report

a. **RATIFIED** – a contract extension for Streetwise, the Council's Wayfinding Consultant for up to 10 days, with a contingency of a further 10 days, with a maximum cost of £11,000 – it was noted that total project costs still remain well within the Wayfinding Budget.

b. **APPROVED** - the creation of 11 .gov emails for use by councillors at an annual cost of about £700 (including support), to be utilised early in the New Year.

#### 6. **RFO Reports**

- a. NOTED the monthly report of income and expenditure against the budget
- b. REVIEWED CIL & Reserve balances
- c. **REVIEW** of Budget lines and **CONSIDERATION of** any virements from unspent funds/reserves to regularise the current budget **DEFERRED** pending 2024/25 budget considerations.

d. **AUTHORISED** - accounts for payment (to be settled subsequent to the meeting) per the appended list, with late items 310, 311, 313, 316 & 317 tabled at the meeting to ensure the meeting of statutory deadlines and prompt payment to small local businesses prior to the extended holiday season.

7. Budget and Precept for FY 2024/25 – after lengthy consideration and partial amendment of the draft budget, it was AGREED that it should be distributed well in advance of the Town Council meeting on January 8<sup>th</sup> for all members to consider. Key proposals included the near complete utilisation of CIL (Community Infrastructure Levy) funds and of other grant funds for several major projects, the recruitment of an additional (junior) member of staff to support the staffing transition agreed at the Council meeting on October 2<sup>nd</sup> and an increase in the Precept to reflect the impact of inflation on the Council's ongoing costs. In addition, Earmarked Reserves were proposed for increase, both in number and allocations.
