- 2. Declarations of Interest None
- **3. Minutes of the Previous Meeting** The minutes for the previous meeting held on the 28<sup>th</sup> November 2023 were approved. From these minutes the Jen Berry Memorial bench was discussed and agreed that the Deputy Clerk would follow up. An update regarding the Holton footpath was given. Work on this has been paused out of respect to the family and ESC has stated that there is still no right of way between path 6 and the public open space.

## 4. Climate Conference review:

- **a. Programme of events** The Committee was asked for suggestions for the programme of events that Halesworth ASH are organising. The Committee approved the request for £1000 towards the programme of events as part of the Climate Conference legacy agreed by the Town Council.

At the recent Marketing Stakeholder Working Group meeting the group looked at success measures for the Marketing Coordinator. There will be a report in September to look back at the first year of the post. Philippa will present her budget for the following year at the March meeting of this committee.

RK has drafted a tree policy (to be sent out with minutes) The Committee will look at this first draft. It was agreed that the main point of the policy is to increase trees in Halesworth and look after the ones already there. A strategy on how to achieve this will also be drafted.
