## Minutes

- 2. Declarations of Interest None
- **3. Minutes of the Previous Meeting –** The minutes of the meeting of the 30<sup>th</sup> July 2024 were agreed and signed by the Chair.
- **4. H-ASH activities/Climate Conference –** around 70 tickets have already been allocated for the Friday night. The exhibition has been set up. The Council's stand has already given out trees. Clerk to send reminder to Cllrs regarding the Friday night panel with ticket link.
  - The committee discussed an environmental policy for the Council. An example from another Council will be circulated as a starting point.
- **5. Youth Development –** St Mary's have been opening one night a week to provide a safe space for 14 18 year olds. The application from St Mary's was for £1000 to provide provisions and equipment for the attendees. The money would be taken from this committee's youth development budget.
  - The committee approved the application of £1000 with the request for feedback during the year and the possibility of a further grant if necessary.
- **6. Skatepark and MUGA/Basketball court (multi use games area)** The Clerk had found a more local company to test the weight capacity of the middle bridge in the town park for the cost of £575 plus VAT. This information could not be sourced from ESC who own the bridge. The Council have received an in budget quote for the MUGA depending on the bridge capacity.
  - The Clerk had sent the skatepark brief to one manufacturer for a ball park figure to renew the equipment. This will then give the Council an idea of costs and if there is a shortfall in funding.
